#### **Legislative Update**

On May 31, Senate Bill 1938 passed the Senate in the early hours of the morning. Unfortunately, it did not make it to the House in time before the session ended. While this was a setback, it will not stop me from fighting for the funding our workers deserve. I will continue this fight during the October Veto Session in Springfield, advocating loudly for substantial transit funding, a designated police force, and meaningful reforms.

We held our annual family cookout and scholarship outing, and based on your feedback, it was a tremendous success. #### Safety

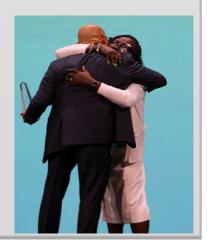

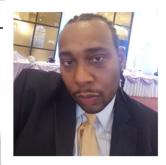

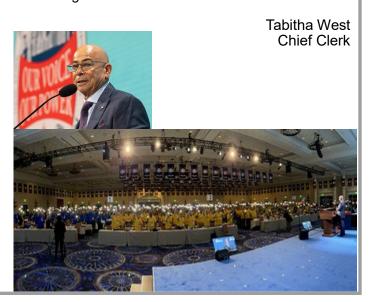
Hello to my Sisters and Brothers of ATU Local 308

At the recent ATU International Convention, Locals from across the United States and Canada came together to address the challenges facing our members and our industry. What took place was not just a series of meetings, but a powerful demonstration of solidarity, strategy, and vision for the future of our union.

One of the most striking lessons came from Florida. There, state lawmakers tried to destroy Locals by eliminating their right to collect dues. With the International's support, Florida Locals fought back—and they won. Their experience is a reminder that such attacks could happen anywhere, and why it is essential for Local 308 and all Locals to remain connected and prepared.

Convention delegates also took a strong stand on safety. Across North America, assaults on transit workers have risen more than 200% in the past decade. Operators have been stabbed, shot, and beaten while simply doing their jobs. The ATU declared clearly: Not one more. The union is pushing for stronger protective barriers, tougher laws, and accountability for agencies that do not safeguard workers.

Beyond safety, the convention also addressed dignity and equity for all members. Resolutions were passed to combat racism, support immigrant workers, end harassment, and strengthen protections for women and LGBTQ+ members. One theme echoed by, many speakers was the essential role of women in leadership, summed up in the phrase: "If you want to get things done, get you a woman on your team."

Finally, delegates looked toward the future of our union. ATU is expanding mentorship and apprenticeship programs to ensure that new operators and mechanics are supported, trained, and ready to step into leadership roles. This investment in the next generation is critical to the survival and strength of our movement.

For Local 308, the message is clear: if we are not present at conventions, our voice is not part of these decisions. By taking part, we help shape the protections, programs, and strategies that directly affect our members here in Chicago.

The 61st International Convention was a reminder of what happens when ATU stands together. We fight, we win, and we build power. Local 308 returns from New York with renewed solidarity and commitment to continue that fight here at home.

These were the opening words of speaker Elise A. Bryant, President of the Coalition of Labor Union Women (CLUW). From August 18-22, 2025, I was a delegate for the 61<sup>st</sup> Amalgamated Transit Unions International convention. This convention was filled with speakers from different unions and union friendly organizations from around the world. Although this wasn't my first, (or my 2<sup>nd</sup>, 3<sup>rd</sup> or 4<sup>th</sup> for that matter) convention, it will be my last as a delegate.

But something was different for me this time. I paid more attention to the number of women involved in the labor movement. There were VERY powerful speeches, Clayola Brown, President of the A Phillip Randolph Institute, spoke on how she would rather be seen than viewed. Women in labor are being seen, and these aren't just woman from the United States either. Sheela Sanja Naikwade, a woman from India, is the State Women's Secretary of the Maharashtra State Transport Kamga Sanghtana (MSTKS) which is a recognized union in India. In a majority male dominated organization, Sheela with the help of other women in the organization help get women placed in every level of leadership.

To bring this closer to home, 308's 1<sup>st</sup> woman President Ethel Carter and our current president Pennie McCoach were both in attendance of the convention. Pennie, who was on a couple of committees spoke very eloquently while speaking about Tim Drea the Illinois President of the AFL-CIO.

The convention started off on Monday, August 18th with welcoming words from President John Costa, International Executive Vice President Yvette Trujillo, and International Secretary Treasurer Kenneth Kirk. President Costa gave encouraging words reminding us that if the table is not moved in our favor during negotiations, we will be forced to meet them in the streets. I learned there have been 13 strikes in the last 3 years since the last convention in 2022, 72% of Americans support unions, we had 3,368 new members join across the ATU, and that 90% of those new members are people under 30 years old.

Throughout the week, we had extremely powerful & dynamic speakers such as the President of the Coalition of Labor Union Women, Elise Bryant, who's chant of "WE ARE, WE ARE UNION!!" got everyone excited. We also had another powerful and inspiring speaker, Terry Melvin. Mr. Melvin is the President of the Black Trade Unions, and he had the entire room uplifted with his preacher style delivery saying "If not you, then who? And if not now then when?!"

We heard from the President of Local 1577, Joey Acevedo of West Palm Beach, FL who gave us an unfortunate news on how in Florida, they not only lost union jobs due to a strike, but they had to do dues check off due to the Trump Administration taking away waivers and they were trying to take away the right to bargain. Fortunately, they were able to successfully get it back, but not all union jobs. We were reminded that at any time it could happen to us, so we must stand strong together in the face of adversity.

One of the most personal highlights for me was having a meeting with Jamaine Gibson, the Director of Apprenticeships and Workforce Development for the ATU, about setting up a mentorship program here in Chicago with our members of Local 308. I also spoke with Leisa Barleston and President Sharon Broderick, from Local 610, our only Local in Charleston, SC who said they were advocating for a train system there.

The 60th International Convention was nothing short of amazing. As a delegate for ATU Local 308 attending this convention, I am even more committed, prouder, and more inspired to get more involved galvanizing our members. It is crucial for us as Union members to understand that we are a powerful force to be reckoned with when we come together and move as a unit. OUR VOICE, OUR POWER!!

It is with great pleasure that I report back to you after performing my elected delegate duties to the 2025 ATU International Convention in New York!

Every three years ATU International has a Convention to facilitate its elections, review constitutional changes, resolutions, financial reports and educate the ATU membership. This is done in a location that can accommodate thousands.

Every ATU Local, through a facilitated vote or by virtue of your office sends delegates to represent their local at the conventions based on the size of their membership. The ATU has approximately 200,000 members between the US and Canada and produces over 600 delegates at the ATU Convention. The convention meetings are held Monday through Friday and last six to eight hours and sometimes longer if you are appointed to serve on a special committee. During the meetings on changes and adoptions are voted on by all the delegates in attendance.

Speeches are given by various guests including elected members from other unions, activists, labor friends and all forms of life.

This year, all speakers conveyed the urgent important message that Unions/Labor must turn up the heat on our labor enemies and the politicians that want to break us and take away our jobs and benefits!! We must do this through engagement, activism, voting and even striking through our membership!

Fiery and unapologetic speeches were offered by President Terry L. Melvin (Coalition of Black Trade Unions), Liz Shuler, President of the AFL-CIO (American Federation of Labor), Sheela Sanjay Naikwade, State Women's Organizing, Secretary, Maharashtra, St from India and many more!

ATU Local 113 (Canada) gave a 1 1/2-hour presentation on how they organized their local to get a 98% support vote from over 12,000 members. They were ready to put their transportation labor into gridlock to get a fair and good contract. Can you imagine if we did that here in Chicago? #### Update on the Retirement Plan and RHCT

As trustees for Local 308, we have worked tirelessly to ensure that your retirement is secure, and your retiree healthcare is protected. We're happy to report that there will be no increase in the contributions you pay to the Retirement Plan or to the Retiree Health Care Trust next year. Although work remains to be done, we've made some significant progress to find creative ways to reduce costs for all members, active and retired.

- Effective Jan. 1, 2022, when we succeeded in getting the law changed, our active members' contributions remained at 1%, lowered from the previous 3% level. This has put on average \$1800/yr. back into active members' pockets each year.
- We have worked tirelessly to keep retiree health care premiums as low as possible. Local 308 led a strong effort to reduce the 2026 rates, but regrettably, the other trustees would not agree to Local 308's proposal to reduce premiums. So, for the second year in a row, 2026 premium rates will remain the same.
- The current rates are significantly lower than they have been in the past; many rates are up to 50% lower than they were in 2018. Here are some examples of how rates have come down:
  - The current non-Medicare PPO plan rate for retirees with 25-29 years of service is \$62 per month lower than it was in 2023, saving you \$744 every year.
  - o The current non-Medicare HMO plan rate for retirees with 30-34 years of service is \$22 per month lower than it was in 2023, saving you **\$264** every year.
  - The Medicare PPO plan for retirees with 25-29 years of service is \$44/month, down from the \$52 rate paid in 2023.
  - o The Medicare PPO plan for retirees with 30-34 years of service is \$18/month, down from the \$21 you paid in 2023.
- HMO, non-Medicare and Medicare rates have all gone down similarly.

As pleased as we are to be able to provide you with this positive report on the Retirement Plan and the Retiree Health Care Trust, we are not satisfied—more work needs to be done. We are committed to ensuring that the contribution rates for active employees and the premiums for retirees remain as low as possible, and that your pensions and retiree healthcare are protected.

Filing a grievance and taking it to arbitration are important tools that the Union can use to challenge unjust discipline and to enforce the contract. An informed membership is absolutely key for the Union to use those tools most effectively. That's why it's so important that all members of Local 308 familiarize themselves with the grievance and arbitration procedures included in Articles 16 and 17 of the collective bargaining agreement. Members can access the agreement and read Articles 16 and 17 by going to the Union's website—atu308.org. Just click the "Important documents" tab in the Membership section and you'll be linked to the current contract as well as older agreements.

#### Here's some important things to know about grievance/arbitration:

What is a grievance? A grievance is a claim that CTA violated collective bargaining agreement, either by disciplining an employee without "sufficient cause" or by taking an action that violates a specific term of the contract. Issues or problems that you may have with CTA that don't involve discipline or a violation of the contract are not grievances, they are complaints. If you aren't sure whether a problem you're having is a grievance or is a complaint, contact the Union office for assistance and your Union officers will advise you.

When does the grievance have to be filed? Grievances must be submitted within 30 days of the occurrence of knowledge of the occurrence giving rise to the grievance. Time limits are "of the essence". If it's filed beyond 30 days, it will be denied as untimely. It is crucial to get your grievance filed on time!

What should be included in the grievance? It should include only the basic facts, such as: "CTA wrongfully disciplined me on [date]". It is also very important to include the remedy you want, such as "I want the discipline removed from my record, and I want to be made whole". It may be tempting to spell out every fact that seems pertinent and/or to identify every argument you want to make, but including those details in the grievance just gives CTA a preview of the Union's arguments. The best approach in writing grievance is to keep it "short and sweet".

#### What happens after I file my grievance? The grievance procedure has steps:

- Step 1: CTA must respond within 30 days of receipt of the grievance. Usually, the Step 1 Answer comes from the employee's work location and includes CTA's justifications for the actions protested by the grievances.
- Step 2: If grievance is not resolved at Step 1, the grievance proceeds to Step 2. At Step 2, the Union Vice Presidents meet with CTA Employee Relations to try to resolve the grievance. If not resolved or answered within 30 days, the next step is arbitration.

<u>What is arbitration?</u> Article 17, the arbitration procedure of the contract, gives an arbitrator, who is a neutral decision maker, the power to resolve the grievance. But an arbitrator only has the power to enforce the contract—an arbitrator cannot award a remedy outside the contract, or change what the contract says, or address matters that don't involve the interpretation or application of the contract. Once an arbitrator issues his decision, that decision is final-there is no appeal process.

Remember, grievance/arbitration procedures are useful tools, but they only work if you use them! Anytime you think that your rights are being violated, contact your Union officers immediately—don't sleep on your rights!

## WE WON!

Brothers and Sisters:

At 4 a.m. this morning, the General Assembly passed legislation that will prevent the catastrophic layoffs that were going to happen next year unless decisive action was taken. Each and every one of you can be assured that your job is safe, and that you can be confident that you can provide for yourself and your loved ones. This was a hard-won victory; it was a real fight to get adequate funding for transit, and not just a stop-gap measure. I also want you to know that, in addition to this crucial funding, the legislation includes some very significant steps towards improving safety and securing more full-time jobs for Local 308 members.

- The legislation provides for the creation of a Law Enforcement Task force to reduce crime on public transit systems and to work on the implementation of a sworn law enforcement crime prevention program to protect employees and riders.
- The regional transit authority (now called NITA) is required to work with Local 308 and Local 241 along with law enforcement, CTA and riders on improving safety.
- CTA is required by the legislation to create Transit Ambassador positions, no less than 80% of which will be full-time positions, and to bargain with Local 308 over the terms and conditions of their employment. Current CSAs will be given priority to be hired into Transit Ambassador positions.

Shortly after I took office, I met with the leadership of the Illinois Federation of Labor to sound the alarm bells regarding the impending fiscal cliff that threatened your livelihood. As a result of that meeting, a coalition of labor unions was organized to work on legislation to stop the financial disaster that was in the offing. That effort came to fruition this morning when the legislation was passed.

#### IMPORTANT INFORMATION REGARDING CTA EMPLOYEES AND THE ILLINOIS WORKERS COMPENSATION ACT

#### **PREFACE**

This summary is designed to be a resource to advise and educate CTA employees to some of the rights and benefits to which they are entitled in the event they sustain a work-related injury. While this summary is not a substitute for the advice of a competent attorney, it is intended to give CTA employees a brief explanation of some

legal issues as well as to illustrate potential pitfalls that can arise which may allow the CTA to contest claims and deny benefits. Please note that all information contained in this summary is valid as of the date of its printing. Please contact us in the event you sustain an injury at work so that we may advise you on how to protect your rights based on the most current Illinois law.

#### **COMPENSABLE CLAIMS**

Not all injuries which occur within the work place are "compensable". **Compensable** refers to a type of injury which entitles an injured worker to payment of benefits under the Workers' Compensation Act. In order for an injury to be **compensable**, it must arise from a risk causally related to the workers' employment. In most instances, this means that the injury must be the result of a specific exertional activity (e.g. lifting, pushing, pulling) or a sudden unexpected event caused by an occupational hazard (e.g. slip on liquid or trip). Injuries which occur as a result of nothing more than everyday movements of the body could be determined to be non-compensable and will be **denied** by the CTA.

#### Example I

Mechanic drops a work order on the floor and feels pain in back bending over to pick it up. This claim is likely to be held non-compensable and denied by the CTA

Mechanic feels pain in back lifting tool box off the ground. This claim is likely to be held to be compensable and accepted by the CTA

#### Example II

Motorman feels sharp pain in knee while walking through rail car. This claim could be determined to be non-compensable and denied by the CTA

Motorman slips on liquid spilled by passenger walking through rail car and feels sharp pain in the knee. This claim is likely to be held compensable and accepted by the CTA

#### PYSCHOLOGICAL CLAIMS

Unfortunately, many CTA employees are injured when they are assaulted physically, visually, or verbally by passengers or other members of the public on platforms or in the stations. Often this results in psychological injury with or without physical injuries. The law regarding these types of claims is extremely complex and the CTA often denies these cases. We have 40 years of expertise in handling these matters. Please contact us immediately if you are assaulted to discuss the facts of your incident.

#### MEDICAL TREATMENT

A CTA employee who has been injured on the job select any two physicians of their own choosing (including any other physician either of the two refer the employee to) and the CTA must pay 100% of the medical bills. The employees' choices do not include doctors or clinics that they are sent by the CTA

#### LOST TIME BENEFITS

When an injured worker is disabled from work, they are entitled to receive tax fee weekly benefits equal to 2/3 of their average weekly salary. The amount of the weekly check is based on the average of the 52 week period prior to the accident. The benefits are to commence on the 4<sup>th</sup> day of the lost time and if the worker is off for a total of 14 days or more, the CTA must pay the 3-day waiting period. Often times, CTA employees experience significant delay in receiving their benefits. Contact us immediately to discuss your situation.

#### STATEMENTS AND VIDEO

Please be aware that any written or recorded statements you provide, the CTA or your doctors can be used by CTA against you to contest your claim. Also, almost ALL accidents which happen in the rail car, the platform or the station are video taped and this video can be used to deny your claim. Accordingly, you should immediately and accurately report all injuries.

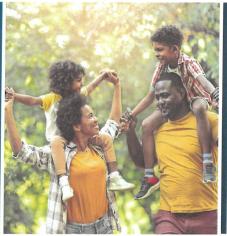
